ORDINANCE 191

ORDINANCE OF THE TOWNSHIP OF NEW SEWICKLEY, BEAVER COUNTY, PENNSYLVANIA FOR ESTABLISHMENT OF A REGIONAL BOARD OF APPEALS THROUGH THE BEAVER COUNTY REGIONAL COUNCIL OF GOVERNMENTS ON MATTERS RELATING TO THE PENNSYLVANIA UNIFORM CONSTRUCTION CODE ACT, AS MAY BE AMENDED FROM TIME TO TIME, AND AS ADOPTED BY THE TOWNSHIP OF NEW SEWICKLEY.

WHEREAS, the Township of New Sewickley adopted Resolution #05-11 conforming to the requirements of the Pennsylvania Construction Code Act, as may have been amended from time to time, and regulations to the Act promulgated by the Pennsylvania Department of Labor and Industry, thereby electing to administer and enforce the building code provisions of the Code; and

WHEREAS, the Township of New Sewickley elected to administer and enforce the Pennsylvania Construction Code Act either through itself or through a third party agency, as provided within the Pennsylvania Construction Code Act; and

WHEREAS, the Beaver County Regional Council of Governments desires, and as permitted by the Pennsylvania Construction Code Act, to establish a Regional Board of Appeals on behalf of its participating, member municipalities, inclusive of the Township of New Sewickley; and

WHEREAS, the Beaver County Regional Council of Governments Board of Delegates authorized the establishment of a Regional Board of Appeals for the purpose of challenging a decision of the Building Code Official as employed by or retained by the Township of New Sewickley; and

WHEREAS, the Township of New Sewickley as a member of the Beaver County Regional Council of Governments, and through its appointed, voting Delegate to the Beaver County Regional Council of Governments, will have a vote in the selection of qualified members of the Regional Board of Appeals.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF NEW SEWICKLEY, that:

 A Regional Board of Appeals be established by the Beaver County Regional Council of Governments in accordance with the Pennsylvania Construction Code Act, as amended from time to time.

- The Regional Board of Appeals will be applicable to the Township of New Sewickley in matters relating to the Pennsylvania Construction Code Act, as amended from time to time, providing a process for challenging decisions made by the Building Code Official as employed by or retained by the Township of New Sewickley.
- The Township of New Sewickley through its membership in the Beaver County Regional Council of Governments and through its appointed, voting delegate, will have a vote on the selection of qualified members on the Regional Board of Appeals.
