

**ORDINANCE NO. 224**

AN ORDINANCE OF NEW SEWICKLEY TOWNSHIP, BEAVER COUNTY, COMMONWEALTH OF PENNSYLVANIA, REPEALING ORDINANCE NUMBER 158 AND AMENDING ORDINANCE NUMBER 204, SO THAT ALCOHOL IS PROHIBITED ON PROPERTY OWNED BY THE TOWNSHIP, INCLUDING GREEN VALLEY PARK, UNLESS APPROVAL IS RECEIVED BY THE BOARD OF SUPERVISORS FOR THE CONSUMPTION OF ALCOHOL AT GREEN VALLEY PARK FOR SPECIAL EVENTS.

WHEREAS, the Board of Supervisors of New Sewickley Township, in 2002, enacted Ordinance No. 158, which provided for consumption of beer in Green Valley Park for events sponsored by the Big Knob and Pine Run fire departments so long as certain conditions were met; and

WHEREAS, the Board of Supervisors, enacted Ordinance No. 204 in 2016, which prohibited the use or consumption of tobacco, nicotine, and alcohol at all Township owned properties, including Green Valley Park;

WHEREAS, the Board of Supervisors desires to repeal Ordinance No. 158 and amend Ordinance No. 204 so that the consumption of alcohol on Township owned property will be prohibited unless the Board of Supervisors approves the consumption of alcohol at Green Valley Park for special events with any conditions that the Board of Supervisors chooses to attach to such approval to protect the health, safety, and welfare of the residents of New Sewickley Township;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Township of New Sewickley, Beaver County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

1. Ordinance No. 158 is hereby repealed and of no further force and effect as of this date.

2. Ordinance No. 204 is amended to allow the Board of Supervisors to approve the consumption of alcohol at Green Valley Park for special events with any conditions that the Board of Supervisors chooses to attach to such approval to protect the health, safety, and welfare of the residents of New Sewickley Township.

3. The complete prohibition of Tobacco and Nicotine as described in Ordinance No. 204 is reaffirmed along with the complete prohibition of alcohol at all other properties owned by New Sewickley Township.

4. All ordinances or parts of ordinances or resolutions conflicting or inconsistent with the provisions of this ordinance are hereby repealed.
