RESIDENT COMMENTS Resident Barbara Cox of Dean Street stated she received the letter from the Township Manager stating the Township would not be taking over the maintenance of Oak Road. She made a plea for help to have the road taken over by the Township and inquired what needed to happen for the request to be honored.

Chairman Happ explained that Oak Road is a private Lane and they would need to have an engineer design plans and the road must meet all specs necessary to be considered a road. At that time, they can present the drawings to the Planning Commission for consideration. He also stated she can contact Manager O'Malley and he can provide her with the necessary specs.

Ms. Cox then stated the drains are not working properly and is causing flooding. Chairman Happ stated the road crew will go out to investigate.
