Ruckert Subdivision Plan

Paul Ruckert was present to explain the lot line revision being requested. Being they met all zoning requirements; the check list was reviewed. The plan needs to be reviewed by the Beaver County Planning Commission.

Motion by Eisenbrown to approve the Ruckert Subdivision with the condition of the plan being approved by the Beaver County Planning Commission, seconded by Braun. Vote of 5-0 in favor.

Comprehensive Plan Updates

Joanne Shelly reviewed the Citizen Participation considerations submitted. Ms. Shelly requested the Planning Commission review the document and make any changes, additions and suggestions they have. She also requested a list of stakeholders and contact information. Chairman Horn requested the Municipal Authority have input in the questionnaire development. Ms. Shelly stated the questionnaire could be ready in 2-3 months to be sent to residences. The goal of the survey is to collect as much comment as possible.

Small Cell Tower Ordinance

The representative from Cohen Law was ill and had to cancel. Discussion occurred on the draft ordinance submitted. The Planning Commission has questions and will need clarification on the ordinance. Chairman Horn requested a video meeting be scheduled at the next scheduled workshop on October 5th. Staff will reach out to Cohen Law and keep the members updated.

537 Plan

Mike Phipps asked if the 537 Plan should be updated at the same time as the Comprehensive Plan or after the Plan is completed. Joanne Shelly, LSSE, stated the Comprehensive Plan update wouldn't affect the update of the 537 Plan. She added the first step is for the Board to form a committee and then select an engineer to complete the update.

Ordinance No. 224 – Revision

The draft Ordinance for alcohol in the park that would replace Ordinance No. 224 was sent to the Township Solicitor for review. The solicitor's comments were received and reviewed. make the requested changes and put the ordinance into legal ordinance form for the October meeting. The Planning Commission can then make a motion to forward to the Board of Supervisors for consideration.
