## NEW SEWICKLEY TOWNSHIP, BEAVER COUNTY

## **RESOLUTION NO. 10-24**

A RESOLUTION OF NEW SEWICKLEY TOWNSHIP, BEAVER COUNTY, PENNSYLVANIA AUTHORIZING THE TOWNSHIP TO INTO INTERGOVERNMENTAL AN COOPERATION AGREEMENT WITH ROCHESTER BOROUGH, BEAVER COUNTY, PENNSYLVANIA TO ALLOW THE TOWNSHIP TO PROVIDE POLICE **FOR SERVICES** SPECIAL **EVENTS** AND/OR **TRAFFIC** CONSTRUCTION DETAILS ON AN AS NEEDED BASIS WITHIN THE BOUNDARIES OF ROCHESTER BOROUGH.

WHEREAS, the Board of Supervisors ("Board") of New Sewickley Township, Beaver County, Pennsylvania ("Township") is vested with the power and authority to make and adopt ordinances, bylaws, rules, and regulations not inconsistent with or restrained by the Constitution and laws of this Commonwealth, as is expedient or necessary for the proper management, care, and control of, *inter alia*, the Township's finances, the maintenance of peace, good government, safety, and welfare of the Township, its trade, commerce, and manufacturers:

WHEREAS, two or more local governments in this Commonwealth may jointly cooperate, or any local government may jointly cooperate with any similar entities located in any other state, in the exercise or in the performance of their respective governmental functions, powers or responsibilities;

WHEREAS, the local governments or other entities so cooperating shall enter into any joint agreements as may be deemed appropriate for those purposes;

WHEREAS, the Township may enter into intergovernmental cooperation with or delegate any functions, powers or responsibilities to another governmental unit, local government or authority upon the passage of an ordinance or resolution by its governing body, the Board of Supervisors; and

WHEREAS, the Board deems it to be in the best interest of the welfare of the Township and its residents to enter into an intergovernmental cooperation agreement with Rochester Borough, Beaver County, Pennsylvania ("Borough") as follows:

- 1. The Rochester Borough Police Department and Rochester Borough requested the assistance of the New Sewickley Township Police Department to staff special events and/or traffic construction details on an as needed basis.
- 2. Pursuant to Title 42 Section 8953 municipal police officers are authorized to have the same power and authority to enforce the laws of this Commonwealth or otherwise perform the functions of that office as if enforcing those laws or performing those functions within the territorial limits of their primary jurisdiction when requested to aid or assist another jurisdiction.

- 3. The purpose and objectives of the Agreement are to allow the New Sewickley Township Police Department to assist the Rochester Borough Police Department on an as needed basis to be determined by the Chief of Police or Officer in Charge of the Rochester Borough Police Department and the New Sewickley Township Chief of Police.
- 4. With regard to the manner and extent of financing the Agreement, Rochester Borough agrees to reimburse New Sewickley Township for the individual officer's overtime rate plus \$5.00 per hour when New Sewickley Township officers are staffing special events. Rochester Borough agrees to reimburse New Sewickley Township at the rate of \$103.00 per officer per hour when New Sewickley Township officers are staffing traffic construction details.

WHEREAS, the conditions of the Agreement are set forth in the Agreement, which is attached hereto as Exhibit A and incorporated as if fully set forth herein; and

WHEREAS, the Agreement will take effect on the date of its execution by both municipalities and run until terminated by either party; and

WHEREAS, each municipality will rely on its ordinary organizational structure to implement the agreement; and

WHEREAS, the Agreement does not require real or personal property to be acquired, managed, licensed or disposed of; and

WHEREAS, the Township is required to state that an entity created under the Intergovernmental Cooperation Act (53 Pa.C.S.A. § 2301 et seq) shall be empowered to enter into contracts for policies of group insurance and employee benefits, including Social Security, for its employees. However, no entity is being created under the Agreement or this Resolution.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of New Sewickley Township as follows:

- 1. The foregoing WHEREAS clauses are incorporated as if set forth herein; and
- 2. The Board hereby authorizes the Township Manager and Township Chief of Police, on behalf of New Sewickley Township and the New Sewickley Township Police Department, to enter into an intergovernmental cooperation agreement with the Borough of Rochester and the Borough of Rochester Police Department as set forth herein and in Exhibit A attached hereto; and
- 3. The provisions of this Resolution shall be effective immediately upon adoption by the Board of Supervisors.
