___ Recorded Operation and Maintenance Agreement (If not completed, an Operation and Maintenance Agreement must be recorded with the Township)

If appeal is related to the Public Education/Involvement Credit, please include the additional documentation. Further, in order to achieve the full credit, a minimum of 20 man-hours must be provided (i.e., 5 people attend event, the event must last 4 hours).

Please note that applications for Public Education/Involvement Credits must be submitted yearly. All applications must be submitted to the Township no later than October 1 of each year and all additional required documentation must be provided to the Township no later than November 30 of each year. The Public Education/Involvement Credits will be applied in the following billing year:
